4. On what basis is my personal data processed?

Scientific research is a task of public interest within the meaning of the GDPR, whereby scientific research of public interest is the basis for processing personal data (Data Protection Act). In the Data Protection Regulation (recital 159), the concept of research also covers RDI activities.

10. How long will my data be stored?

11. How will my personal data be protected?

Your personal data is stored in an information system. Users have personal user IDs. Only data controllers who are entitled to access and use the system by virtue of their job are allowed to do so.

Customer and stakeholder data are stored in a customer management system, where data maintenance is protected by an AD ID and password. The data stored in the system are accessible by a restricted group of users with user rights.

- the right to object to processing
- the right not to be subject to automated decision-making without legitimate grounds
