#### 3. Purpose of Processing Personal Data

Personal data is processed:

- As part of the project's activities and to implement the university's research, development, and innovation activities (RDI activities).
- As part of data collection to assess impacts and achieve objectives.
- To manage stakeholder cooperation and customer relationships, inform about the project's activities and results, and for scientific research.

#### 4. Legal Basis for Processing Personal Data



The legal basis is the public interest (scientific research and the research, development, and innovation activities of universities of applied sciences) and the data subject's consent. Personal data is also processed based on legitimate interest, for example, during event registrations.

The processing of personal data in scientific research is based on the EU General Data Protection Regulation and national data protection law. Scientific research is considered a task carried out in the public interest according to the GDPR, making it a legal basis for processing personal data (Data Protection Act). The GDPR (Recital 159) also covers RDI activities.

### 6. Parties and Responsibility Sharing in Collaborative Research

The project is implemented and administered by South-Eastern Finland University of Applied Sciences (Xamk). In certain situations, the purposes and means of processing personal data may be determined, for example, by an individual researcher or a research group. Such cases must always be assessed separately.

#### 7. What Information is Processed About Me?

Possible personal data processed includes name, organization, job title, hometown, and contact information (email or phone number).

## 8. From What Sources is My Information Collected?

We collect personal data from the data subjects themselves. Information is collected from event registration forms and participant lists and possibly from surveys conducted during the project.

#### 9. Is My Personal Data Disclosed to Third Parties?

Data is not disclosed to third parties, i.e., outside the project actors. Xamk may use external personal data processors (e.g., companies providing IT services such as Microsoft), which process personal data according to agreements.

### 10. Is My Data Processed Outside the EU or EEA?

Data is not transferred outside the EU or EEA by the data controller.

Xamk uses Microsoft cloud services (Teams and OneDrive) for storage. Microsoft primarily processes data within the EU/EEA and regional data centers. Microsoft is committed to complying with the EU General Data Protection Regulation. ## 11. How Long is My Data Retained?

Personal data is retained for the duration of the project and as long as there is a need for its use. In project activities, personal data is retained according to the funder's required archiving period. Project materials and data, which may contain personal data, are archived according to Xamk's practices for 10 years.

### 12. How is My Personal Data Protected?



The data is stored in an information system. Users have personal user IDs. Only those employees of the data controller who have the right to access the data for their work can access and use the data in the system.

Customer and stakeholder data is stored in a customer management system, where data maintenance is protected by an AD ID and password. The data stored in the system is available to a restricted group with user rights.

- · Right to object to data processing
- Right not to be subject to automated decision-making without legal
