### 3. What is the purpose for which my personal data is processed?

Project aims to improve safety of oil spill response by providing measurement data on concentrations of hazardous substances and ignition hazards during spill response and recovery. Personal data is processed upon registration for the project events/training courses and/or test sessions and if necessary for contact in notification matters related to the mentioned events/activities.

### 4. On what basis is my personal data processed?

The legal basis for the processing of personal data is public interest (scientific research and research, development and innovation activities of universities of applied sciences.

The processing of personal data in scientific research is based on the EU's General Data Protection Regulation and national Data Protection Act. Scientific research is a task in the public interest within the meaning of the Data Protection Regulation, in which scientific research in the public interest is the basis for the processing of personal data (Data Protection Act). In the Data Protection Regulation (recital 159), the concept of research also covers RDI activities.
