### 4. On what basis is my personal information processed?

Public task

The processing of personal data in scientific research is based on the general EU data protection regulation as well as national data protection law. Scientific research is a task in the public interest within the meaning of the Data Protection Regulation, in which case scientific research in the public interest is the basis for the processing of personal data (Data Protection Act). In the Data Protection Regulation (recital 159), the concept of research also covers RDI activities.

Every partner organization has named the project groups and primary contact persons. Xamk as the lead applicant holds the main responsibility of the project management, invites partners to join the regular project meetings. Xamk is also responsible for the WP2 "Developing dialogue workshops – Defining good practices and key challenges in combining peace education to youth work". WP2 includes arranging workshops and collecting personal data for these. This also includes obtaining individual consent for pictures and materials, which will be used in the PEACE4Europe-project.



Rauhankasvatusinstituutti Ry and Gyermek- és Ifjúsági Önkormányzati Társaság are responsible for WP3 "Development of Youth Worker as a Peace Educator educational material package", which includes international meetings and production of educational material.

BEST Institut für berufsbezogene Weiterbildung und Personaltraining GmbH is responsible for WP4 which includes evaluation of the project. MONDO MTU - NGO MONDO and EESTI NOORSOOTOOTAJATE KOGU are responsible for WP5 which includes dissemination and outputs of the project.

## 7. From what sources is my information collected?

Personal data is obtained directly from the subject.

## 8. Will my personal information be disclosed to third parties?

The information is not regularly disclosed to other parties. The information may be published to the extent agreed with the data subject. Certain information may be disclosed to the project funder Finnish National Agency for Education, in connection with reporting on matters required, e.g. lists of participants in the events.

## 9. Is my data processed outside the EU or the EEA?

Data will not be transferred by the controller outside the EU or the EEA.
